TERMS AND CONDITIONS:

1. Valid for return trips, for journey originating from PBH only.
2. The above fares are for sale with immediate effect.
3. Valid for travel during the off season months of DEC 2013, JAN 2014 AND FEB 2014.
4. All journeys must be complete by 28th of February 2014.
5. Ticket validity: 21 days from date of travel.
6. Date change as per tariff manual but only within the validity of the ticket.
7. CHILD FARE: 75% of the FIT fare.
8. INFANT FARE: 10% of the normal published fare.
9. Refundable if one leg used taking the full one way fare. No refund for unutilized tickets.
10. Original citizen ID card must be produced during the time of ticketing and a copy must be kept for record in order to avail the SENIOR CITIZEN FARE.
11. NON REROUTEABLE, NON ENDORSEABLE.
12. GIT: GV4 must consist of minimum 4 adult passengers travelling on same flights and dates.
13. Fare codes must be inserted on all tickets sold or full fare will be debited for sales submission.
14. TO BE SOLD BY Drukair offices in Paro and Thimphu only.
15. TTL: One week from date of booking with a minimum of 10 days from date of travel.
16. For B2B users normal TTL rules as per the B2B system will apply.
17. The above fares are exclusive of all taxes applicable.
18. Above fares applicable only on classes mentioned.
19. For Indian nationals, OSD on S class is applicable only on Indian sectors.
20. Tour conductor's rebate CG not applicable on the above fares.
